## Project Overview

The Creston Annex Head Start Stormwater Project (4620 SE Powell Blvd, Portland, OR 97206) managed by the Lower Columbia Estuary Partnership will capture and treat stormwater and provide nature play opportunities for students. The western portion of asphalt parking lot will be retrofit with vegetated stormwater facilities and sidewalks, permeable pavers will replace the eastern portion of the parking lot and alley, and the northeastern turf area will be landscaped with native plantings and outdoor play elements for students. The project was developed by KPFF in collaboration with Learning Landscapes and PPS.

This is a BOLI prevailing wage project, and bidder must be able to meet City of Portland insurance requirements outlined in the General Conditions, section 10.

## Approach and Schedule

Bidder shall attach a proposed Project Approach and Schedule with key milestones to the Bid Form. The schedule shall show work completed between June 15, 2026 – October 31, 2026. The schedule shall show parking lot substantial completion and all parking spaces open to parking and front door access by August 14, 2026, habitat garden substantial completion and planting complete by October 31, 2026. The attachment shall not exceed two (2) 8.5x11" pages.

## Statement of Qualifications

Bidder shall attach a statement of qualifications (maximum of two (2) 8.5x11" pages), which shall include three (3) similar projects, including the date, location, cost, contact for a reference, and a short project description. Bidder also shall attach a resume for the Project Manager/Site Superintendent, which may be a maximum of two (2) additional 8.5x11" pages.

# BID ITEM LIST DESCRIPTIONS

## **1. Mobilization**

Includes all administrative setup and closeout, staging, temporary fencing, erosion and sediment control (BMPs), site signage, temporary utilities, access and parking controls, and other general conditions required to initiate and complete construction.

## **2. Site Demolition**

Remove and dispose of existing pavements, structures, and other elements as shown on plans. Includes proper waste management and erosion control.

## **3. Parking Lot Furnishings**

Install parking lot features including concrete curbs, sidewalk, asphalt paving and patching, wheel stops, pavement markings, and parking lot signage.

## **4. Stormwater Planter**

Install parking lot stormwater planter including concrete walls, asphalt patching, check dams, soil, subgrade, catch basin, overflow structure, and pipework (does not include plants).

## **5. Fencing and Gates**

Furnish and install chain link fence and gates.

## **6. Permeable Pavers**

Furnish and install permeable pavers.

## **7. Landscape (parking lot)**

Furnish and install soil, seed, and plants, and soil preparation.

## **8. Backflow Prevention**

Furnish and install backflow protection unit.

## **9. Trash Enclosure**

Build trash enclosure according to structural construction drawing sheets S001 – 005 and S401.

## **10. Habitat Garden Furnishings**

Furnish and install benches and boulders, concrete path, and nature play elements.

## **11. Landscape (habitat garden)**

Furnish and install soil, seed, and plants, sod removal and soil preparation.
