

## **Columbia River Basin Act passes US Senate**



The Columbia River Basin Restoration Act (CRBRA) - which will bring millions of dollars to the region to improve the river's water quality - is one step closer to becoming reality. September 15, 2016, the U.S. Senate passed the Act as part of the Water Resources Development Act of 2016, a bill that addresses critical fish and wildlife habitat, water quality, and infrastructure needs in 18 states. The CRBRA authorizes a grant program administered by the U.S. EPA to help local groups voluntarily clean up, monitor, and reduce the use of toxics within the Columbia River Basin. Since 2009, we have worked with members of Congress to bring attention to the Columbia River and secure critical funding to improve the river's water quality and clean up toxics. Thanks to US Senator Merkley and Congressman Blumenauer for championing the CRBRA. The House of Representatives passed its own WRDA bill, but it did not include the CRBRA. Our next step is to see if it can be added as the House and Senate bills go through the conference committee process.
