



Congresswoman Bonamici visits Batwater Station Floodplain Restoration Site

In early September, we had the honor of taking Congresswoman Suzanne Bonamici (OR 1) on a tour of one our restoration projects at Batwater Station Floodplain near Clatskanie. Landowners Michael and Karin Hunt, Estuary Partnership Board member and Lower Columbia Watershed Council Coordinator Margaret Magruder, as well as staff from the Columbia Soil & Water Conservation District met



Congresswoman Bonamici and walked her through the project, which recently removed a dike. The project is restoring the natural hydrology of the eastern portion of the property, allowing fish passage and providing key rearing habitat for migrating juvenile salmonids. It was a unique opportunity to give the Congresswoman a first-hand look at the work underway to restore wetlands on the Columbia River. We also gave the Congresswoman additional information on toxics in the Columbia River Basin and discussed the importance of the [Columbia River Basin Restoration Act](#). La Center Wetlands Restoration Underway

In September, the Estuary Partnership began construction on the **La Center Wetlands Restoration project**, located on the East Fork Lewis River near La Center, Washington. The project will reconnect 453 acres of historic floodplain habitat to the East Fork. To restore natural hydrology and allow fish to access the site, we will breach two levees in four locations, remove a weir and a culvert that are fish passage barriers, and re-meander an engineered channel so it is more sinuous. The project will restore habitat for numerous species, including various waterfowl, beaver, amphibians, reptiles, and juvenile salmonids. Construction will conclude by the end of October 2015. Additionally, we will be planting over 60,000 trees and shrubs over another 30 acres and engaging La Center students and community members to plant more than 4,000 trees and shrubs along
